

1 **Relating to:** commemorating the achievements and contributions of the Veterans  
2 of Foreign Wars of the United States of America on the occasion of its  
3 centennial.

4 Whereas, the Veterans of Foreign Wars of the United States of America traces  
5 its roots back to 1899, when veterans of the Spanish-American War banded together  
6 and formed organizations, that would become what is known as the Veterans of  
7 Foreign Wars of the United States of America, to help fellow veterans secure pension  
8 rights and other benefits for those who served their country; and

9 Whereas, the Veterans of Foreign Wars of the United States of America was  
10 officially incorporated in the District of Columbia in 1914 and by Congressional  
11 Charter on May 28, 1936; and

12 Whereas, the Veterans of Foreign Wars Department of the great state of  
13 Wisconsin called to order its first organizational meeting on June 6, 1921, and has  
14 since provided dedicated service to Wisconsin veterans, their families and our  
15 communities; and

1           Whereas, today the 2,000,000 members of the Veterans of Foreign Wars of the  
 2           United States of America continue its proud heritage by providing assistance to  
 3           veterans and their families in obtaining entitlements and benefits, advocating  
 4           legislation on behalf of veterans and serving the needs of our country; and

5           Whereas, service projects of the Veterans of Foreign Wars of the United States  
 6           of America community contribute more than 14,000,000 hours of volunteer service  
 7           each year to benefit veterans hospitals, youth programs, patriotic endeavors,  
 8           environmental efforts, safety instruction and thousands of local community  
 9           activities, and provide more than \$2,700,000 in college scholarships, awards and  
 10          other incentives to high school students across the nation; and

11          Whereas, today the Veterans of Foreign Wars of the United States of America  
 12          is the nation's oldest major veterans organization and continues to fulfill the  
 13          commitment adopted by its founders in 1899: "Honor the Dead By Helping the  
 14          Living"; and

15          Whereas, the members of the Veterans of Foreign Wars of the United States of  
 16          America are individuals blessed with uncommon courage, integrity, valor and honor,  
 17          who made a personal commitment to our country; now, therefore, be it

18          *Resolved by the senate, the assembly concurring, That* the members of the  
 19          Wisconsin legislature salute the Veterans of Foreign Wars of the United States of  
 20          America for 100 years of service to our country, to the comrades of the veterans and  
 21          to their families, and to our communities; and, be it further

22          *Resolved, That* the ~~senate~~ chief clerk shall transmit a copy of this joint  
 23          resolution to the Veterans of Foreign Wars Department of the great state of  
 24          Wisconsin.

If the analysis indicates that a fiscal estimate is required because the proposal makes an appropriation or increases or decreases existing appropriations or state or general local government fiscal liability or revenues, you have the option to request the fiscal estimate prior to introduction. If you choose to introduce the proposal without the fiscal estimate, the fiscal estimate will be requested automatically upon introduction. It takes about 10 days to obtain a fiscal estimate. Requesting the fiscal estimate prior to introduction retains your flexibility for possible redrafting of the proposal.
