1 At the locations indicated, amend the joint resolution as follows:

2 ✓ 1. Page 1, line 12: delete "during the past month dairy prices have fallen
3 sharply by" and substitute "actions of the U.S. Department of Agriculture have led
4 to the dairy price drop of". (13)

5 2. Page 1, line 4: after that line insert: "Whereas, the ~~United States~~
6 Department of Agriculture has been unwilling to change its milk pricing system
7 based on how far from Eau Claire, Wisconsin, the farm is located; and

8 Whereas, a law¹suit initiated in Minnesota had this current pricing system
9 thrown out; and

10 Whereas, the failure by ~~Secretary Glickman~~ *U.S. Department of Agriculture*
11 for the upper Midwest, while at the same time allowing for the Northeast Dairy

Whereas a law suit initiated in Minnesota had this current pricing system thrown out. Failure by Secretary Glickman to implement a fair pricing policy to the upper Midwest, while at the same time allowing for the Northeast Dairy Compact, which allows the New England States to price its milk higher to the disadvantage of the upper Midwest, has hurt Wisconsin Dairy farmers.
