Bud Dutton, Chairman and his National Airborne Day Committee, are preparing new language to reflect that this is an effort of the entire AIRBORNE Community; not just our Association's goal. However, our Chapters and their members will need to lead by example, making personal contact, or writing their Senators requesting that they cosponsor the new resolution.

At this time, we do not know whether the House of Representatives will renew a procedure for commemorative resolutions which they stopped in 1992. Executive Director DeJesus will, be providing a listing of current Senators and a sample letter in the monthly Bulletin for your use.

Chapters and members should continue to call upon governors, state legislatures and local governments to issue non-year (perpetual) resolutions. The committee urges all active airborne military units to recognize August 16 in their training schedule and event activity. Chapters should also plan an Airborne event for the 16th, or as close to the date as possible, follow the Association Communications and Public Relations SOP to obtain maximum media coverage.

Don Lassen will continue to contact the leaders of other Airborne Associations via the *Static Line*, urging their active participation. This is our third year on this project and we can't strike out. Let's help Bud and his committee, to help all of us make National Airborne Day a reality. In addition to Bud, Strom, Don, Manny and myself, other committee members are Past President O'Brien, Ken Leggett, Gordon Sumner, and Steven Mrozek.

Vesignating August 16 1997 (as National Airborne Day

Whereas the Parachute Test Platoon was authorized by the War Department on June 25, 1940, to experiment with the potential use of airborne troops;

Whereas the Parachute Test Platoon was composed of 48 volunteers who began training in July 1940;

Whereas the Parachute Test Platoon performed the first official Army parachute jump on August 16, 1940;

Whereas the success of the Parachute Test Platoon led to the formation of a large and successful airborne contingent serving from World War II until the present;

Whereas the 82d Airborne Division was the first Airborne Division that was organized following the successes of the Parachute Test Platoon and the early airborne training

program and has continued in active service since its creation; Whereas the 82d Airborne Division Association exists to continue and foster that special esprit de corps among fellow paratroopers, to perpetuate the memory of the 82ft Airborne Division troopers who fought and died for our Xation, and to further the common bond among all members of the airborne community; and Whereas the 82d Airborne Division Association, during the 52d year of existence and at the 50th Annual Convention, adopted a resolution to perpetuate the memory of the Parachute Test Platoon's "Jump Into History" on August 16, 1940 Your therefore, be it designates August 16 1987 Airborne Day and requests that the President issue a proclamation calling upon the Federal, State, and local ad-5 ministrators and the people of the United States to observe the day with appropriate programs, cere monies and activities.
