## 1999 ASSEMBLY JOINT RESOLUTION

1     **Relating to:** creating a committee of conference on 1999 Assembly Bill 133, the  
2             executive budget bill of the 1999 legislature.

3             *Resolved by the assembly, the senate concurring, That,* upon the adoption  
4     of this joint resolution by the senate and concurrence therein by the assembly and  
5     notwithstanding joint rule 3 (intro.), there is created a committee of conference on  
6     1999 Assembly Bill 133, relating to state finances and appropriations, constituting  
7     the executive budget bill of the 1999 legislature, to reconcile the differences between  
8     the 2 houses and to present its report on the bill to the 2 houses; and

9             *Be it further resolved, That,* notwithstanding joint rule 3 (1), senate rules 4  
10     (9) and 35 and assembly rule 40 (1):

11             (1) The committee of conference on 1999 Assembly Bill 133 shall consist of 3  
12     members from each house ~~representing the majority party in each house.~~

13             (2) The members of the committee of conference on 1999 Assembly Bill 133  
14     shall be appointed by the speaker of the assembly in the case of assembly members

1 and be appointed by the president of the senate, without approval of the senate, in  
2 the case of senate members.

3 (3) The report by the committee of conference on 1999 Assembly Bill 133 must  
4 be supported by the votes of at least a majority of the members representing each  
5 house.
