1 Relating to: domestic violence awareness. ✓

2 Whereas, the state of Wisconsin on behalf of the Wisconsin Coalition Against
3 Domestic Violence proclaims October as Domestic Violence Awareness Month; and

4 Whereas, October 1, 1999, is the National Work to End Domestic Violence Day;
5 and

6 Whereas, in conjunction with Domestic Violence Awareness Month, October 4,
7 1999, is being observed as the Day of Unity for victims of domestic violence; and

8 Whereas, by observing Domestic Violence Awareness Month, National Work to
9 End Domestic Violence Day and the Day of Unity, we seek to further greater
10 awareness of the incidence of violence in the home, focusing on the victims of
11 domestic violence and their children who have suffered emotional and physical
12 abuse; and

13 Whereas, through the inspiration, courage and persistence of victims of
14 domestic violence, their children and advocates, legislation has been enacted to
15 provide protection and services for those victims and their children; and

1 Whereas, the achievements of those working to end domestic violence
2 throughout the state and the nation, together with the continuing efforts of this state
3 to assist victims of domestic violence, are to be commended; now, therefore, be it

4 ***Resolved by the assembly, the senate concurring, That*** ✓ the members of the
5 Wisconsin legislature hereby proclaim October as Domestic Violence Awareness
6 Month; October 1, 1999, as the National Work to End Domestic Violence Day; and
7 October 4, 1999, as the Day of Unity in the effort to promote an awareness of the
