This joint resolution requires a committee of conference to meet on the call of either cochairperson.

Resolved by the assembly, the senate concurring, That:

SECTION 1. Joint rule 3 is renumbered Joint rule 3 (1) and Joint rule 3 (1) (a), as renumbered, is amended to read:

Joint Rule 3 (1) (a) The usual manner of procedure is as follows: If a bill of one house has been amended and passed by the other house, and has been returned to the house of origin and that house has refused to concur in an amendment, such house may appoint a committee of conference and notify the other house which shall appoint a committee of conference unless it votes to recede from its amendment. Such committees shall be appointed by the presiding officer, but senate committees shall be confirmed as are standing committees. The joint committee shall, at a convenient

hour agreed upon, meet and state to each other, verbally or in writing, the reasons
of their respective houses for or against the disagreement, and confer thereon, and
