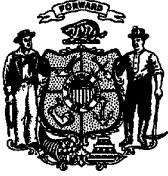

1 **To amend** joint rule 3 (intro.); **relating to:** minority representation on committees  
2 of conference.

This joint resolution requires that at least one member from each house be a member of the minority party.

3 ***Resolved by the assembly, the senate concurring, That:***

4 **SECTION 1.** Joint rule 3 (intro.) is amended to read:

5 Joint Rule 3 (intro.) Committee of conference <sup>3</sup> In all cases of disagreement  
6 between the senate and assembly on amendments, adopted by either house to a bill  
7 or joint resolution passed by the other house, a committee of conference consisting  
8 of 3 members from each house may be requested by either house, and the other house  
9 shall appoint a similar committee. At least one member from each house shall be a  
10 member of the minority party. ✓

If the analysis indicates that a fiscal estimate is required because the proposal makes an appropriation or increases or decreases existing appropriations or state or general local government fiscal liability or revenues, you have the option to request the fiscal estimate prior to introduction. If you choose to introduce the proposal without the fiscal estimate, the fiscal estimate will be requested automatically upon introduction. It takes about 10 days to obtain a fiscal estimate. Requesting the fiscal estimate prior to introduction retains your flexibility for possible redrafting of the proposal.
