## **TO 1999 ASSEMBLY JOINT RESOLUTION 93**

Noon

At the locations indicated, amend the joint resolution as follows:

1. Page 1, line 2: delete "and judges".

2. Page 1, line 7: delete "or judge of any court of record" and substituted "or judge of any court of record".

3. Page 2, line 2: after "qualified." insert "When a vacancy occurs in the office of judge of any court of record, the vacancy shall be filled by appointment by the governor, which shall continue until a successor is elected and qualified."
