TO 1999 ASSEMBLY JOINT RESOLUTION 93

1 At the locations indicated, amend the joint resolution as follows:

2 1. Page 1, line 2: delete "and judges".

3 2. Page 1, line 7: delete "or judge of any court of record" and substitute "or
4 judge of any court of record".

5 3. Page 2, line 2: after "qualified." insert "When a vacancy occurs in the office
6 of judge of any court of record, the vacancy shall be filled by appointment by the
7 governor, which shall continue until a successor is elected and qualified."
