

2. Page 4, line 21: delete "The adjustment" and substitute "The mechanism shall adjust the amount of a limitation so that total costs are not increased as a result of the transfer. The adjustment".
3. Page 8, line 6: delete lines 6 to 11 and substitute "governmental unit for those costs".
4. Page 8, line 12: before that line insert:  
 "(9) (a) Except as provided in par. (b), the proportion of costs of all other governmental units, taken as a group, that the state pays shall not be reduced below that proportion in effect on the first day that occurs after the ratification of this section.
