TO 1999 ASSEMBLY JOINT RESOLUTION 112

1 At the locations indicated, amend the joint resolution as follows:

2 1. Page 2, line 18: delete "Beginning" and substitute "Except as otherwise  
3 provided in this subsection, beginning".

4 2. Page 2, line 24: after that line insert:

5 "(3) If a parcel specified in sub. (2) is substantially improved, as defined by the  
6 legislature by law, the owner of the parcel shall pay the property taxes on the parcel  
7 for the year in which the improvement is made as if sub. (2) were not in effect and  
8 in each subsequent year the property owner shall pay the property taxes as limited  
9 by sub. (2).".
