Be it further resolved, That, notwithstanding joint rule 3 (intro.) and (1) and senate rule 4 (9):

(1) The committee of conference on 1999 Senate Bill 450 shall consist of 4 members from each house, with 3 members from each house representing the majority party in that house and one member from each house nominated by the minority leader in that house.
