**1999 ASSEMBLY JOINT RESOLUTION**

*Now*

1 **Relating to:** creating a committee of conference on 1999 Senate Bill 125, relating  
2 to operating a motor vehicle while under the influence of an intoxicant or drugs,  
3 or both; installation of an ignition interlock device in cases involving  
4 intoxicated operation of a motor vehicle; seizure of motor vehicles for offenses  
5 related to driving while under the influence of an intoxicant; the prohibited  
6 alcohol concentration related to operating a motor vehicle while under the  
7 influence of an intoxicant; creating a safe-ride grant program; certain alcohol  
8 beverage offenses committed by persons under the legal drinking age; making  
9 an appropriation; and providing penalties.

10 **Resolved by the assembly, the senate concurring, That,** upon the adoption  
11 of this joint resolution by the assembly and concurrence therein by the senate and  
12 notwithstanding joint rule 3, there is created a committee of conference on 1999  
13 Senate Bill 125, relating to operating a motor vehicle while under the influence of  
14 an intoxicant or drugs, or both; installation of an ignition interlock device in cases  
15 involving intoxicated operation of a motor vehicle; seizure of motor vehicles for

1 offenses related to driving while under the influence of an intoxicant; the prohibited  
2 alcohol concentration related to operating a motor vehicle while under the influence  
3 of an intoxicant; creating a safe-ride grant program; certain alcohol beverage  
4 offenses committed by persons under the legal drinking age; making an  
5 appropriation; and providing penalties, to reconcile the differences between the 2  
6 houses, as reflected by 1999 Senate Bill 125 as engrossed by the senate and 1999  
7 Assembly Bill 221 as engrossed by the assembly, and to present its report on the bill  
8 to the 2 houses; and ✓

9 ***Be it further resolved, That,*** notwithstanding joint rule 3 (intro.) and (1),  
10 senate rules 4 (9) and 35 and assembly rule 40:

11 (1) <sup>AA</sup> Neither bill need receive 3 readings.

12 (2) The committee of conference on 1999 Senate Bill 125 shall consist of 4  
13 members from each house, with 3 members from each house representing the  
14 majority party in that house and one member from each house nominated by the  
15 minority leader in that house.

16 (3) The members of the committee of conference on 1999 Senate Bill 125 shall  
17 be appointed by the speaker of the assembly in the case of assembly members and  
18 be appointed by the president of the senate, without approval of the senate, in the  
19 case of senate members.

20 (4) The report by the committee of conference on 1999 Senate Bill 125 must be  
21 supported by the votes of at least a majority of the members representing each house.
