### 1999 ASSEMBLY JOINT RESOLUTION

*Authorizing the joint committee on legislative organization to*

1 **Relating to:** extending ~~for one day~~ the legislative floor period commencing ~~in~~ March  
2 7, 2000, solely for the consideration of 1999 Assembly Bill 892 and 1999 Senate  
3 Bills 493 and 494, the "1999 Professional Football Stadium Bill".

4 **Resolved by the assembly, the senate concurring, That,** notwithstanding  
5 1999 Senate Joint Resolution 1, section 1 (2) (p), the floor period commencing on  
6 March 7, 2000, is extended for ~~one day~~ solely for the purpose of consideration of 1999  
7 Assembly Bill 892 and 1999 Senate Bills 493 and 494.
