## 1999 ASSEMBLY JOINT RESOLUTION

*Noa*

1 **Relating to:** the final adjournment of the May 2000 extraordinary session.

2 ***Resolved by the assembly, the senate concurring, That:***

3 **SECTION 1. Adjournment.** Except for the consideration of executive vetoes or  
4 partial vetoes, the adoption of and concurrence in this joint resolution by both houses  
5 and a motion to adjourn pursuant to this joint resolution adopted in each house shall  
6 constitute the final adjournment of the May 2000 extraordinary session of the  
7 legislature.

8 **SECTION 2. Veto review.** The May 2000 extraordinary session shall reconvene  
9 upon a call of a majority of the members of the joint committee on legislative  
10 organization solely for the consideration of executive vetoes or partial vetoes.
