1 **Relating to:** the life and public service of William N. Belter.

2           Whereas, William N. Belter was born on July 7, 1926, and died on December  
3 12, 1999; and

4           Whereas, after graduating from Wautoma High School in 1944, he continued  
5 his education at the University of Wisconsin, ultimately receiving his law degree in  
6 1949; and

7           Whereas, in addition to his law career, he constantly devoted himself to public  
8 endeavors, serving as Justice of the Peace from 1947 to 1960, and as Waushara  
9 County District Attorney from 1968 to 1979; and

10           Whereas, William N. Belter served in the Wisconsin Assembly from 1953 to  
11 1957, where he was chairman of the Committee on Contingent Expenditures; and

12           Whereas, in addition to the law and public service, William Belter's activities  
13 included service as a director and president of Union State Bank; and

14           Whereas, he also operated a restaurant and was comanager of Belter Tube  
15 Bending in Wautoma; and

1           Whereas, William Belter was Wautoma's great globe-trotter, whose enthusiasm  
2 for other climes and cultures made each journey abroad a true voyage of discovery;

3 now, therefore be it

4           ~~Resolved by the assembly, the senate concurring;~~ *That* the members of the  
5 ~~Legislature~~ *assembly* honor William N. Belter for a distinguished career of public service, and  
6 mourn his passing; and, be it further

7           *Resolved, That* the assembly chief clerk shall provide copies of this resolution  
8 to William Belter's wife *Alcina*; his daughters, Alessandra and Babette; and his son,  
9 Endre.
