1 At the locations indicated, amend the resolution as follows:

2 **1.** Page 1, line 2: delete "capacity" and substitute "capacity and prohibiting
3 certain travel by members of the 1999 assembly".

4 **2.** Page 2, line 19: after that line insert:

5 ***Resolved, That*** no member of the 1999 Wisconsin assembly may, at taxpayer
6 expense, attend or travel to any meeting or event held or sponsored by a national or
7 regional organization of legislatures that has South Carolina as a member, or
8 organization of legislators that has legislators from South Carolina as members,
9 while the state of South Carolina flies the confederate flag in an official capacity; and,
10 be it further".
