1999 ASSEMBLY RESOLUTION

Resolved by the Assembly, That:

Relating to: establishing a special order of business for Friday, March 24, 2000.

SECTION 1. Special order scheduled. The following proposal shall be a special order of business on Friday, March 24, 2000, at the time shown:

(1) At 9:00 a.m., 1999 Assembly Bill 892, relating to: creating a local professional football stadium district; giving a local professional football stadium district the authority to issue bonds; making a state moral obligation pledge with respect to bonds issued by a local professional football stadium district; giving a local professional football stadium district the authority to impose a sales tax and a use tax; state aid for transportation facilities associated with a professional football team's home stadium; and making appropriations.

SECTION 2. Twelve hour notice. Consideration of the special order of business established in Section 1 of this resolution shall occur at the time shown in that section or 12 hours after adoption of this resolution, whichever is later.
