- ① **Relating to:** proclaiming the week of March 26, 2000, as ^{open} Volunteer Firefighter ^{quarters} & ^{and} and
- ② EMT Professional Appreciation Week.
- 3 Whereas, volunteer firefighters and emergency medical technicians (EMTs)
- 4 risk their lives on a daily basis to help others; and
- 5 Whereas, volunteer firefighters and EMTs respond to emergency calls at all
- ⑥ hours of the day and often leave their ^{families and} full-time jobs and families on a minute's notice;

- ⑩ Whereas, over eight hundred ⁸⁰⁰ fire departments in Wisconsin employ the

- ⑫ Whereas, the contributions and sacrifices of volunteer firefighters, EMTs, and

Requesting the fiscal estimate prior to introduction retains your flexibility for possible redrafting of the proposal.
