1. Page 2, line 18: after that line insert:

"SECTION 3m. Nonstatutory provisions.

(1) Notwithstanding section 20.928 (1) of the statutes, during the 1998-99 fiscal year and the 1999-2001 fiscal biennium, the board of regents of the University of Wisconsin System may not include in any certification to the department of administration under section 20.928 (1) of the statutes ^{sub. (1)} any sum to pay the costs resulting from employer contributions for the payment of health insurance premiums for any teacher described under section ^{5.} 40.02 (25) (b) 1m. ~~of the statutes,~~ ~~as created by this act~~ for coverage before the first day of the 7th month beginning after the teacher begins employment with the state."
