1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1, line 4: delete that line and substitute:

3 "157.114 Duty to provide for burials. (1) In this section, "cemetery
4 authority" does not include a municipality that takes control of a cemetery under s.
5 157.115 (1) (b)[√] or a town board that takes charge of a cemetery under s. 157.115 (1)
6 (c)[√]."

7 [√]**2.** Page 1, line 5: before "practicable" insert "(2) A cemetery authority shall,
8 insofar as".

9 **3.** Page 1, line 6: delete "section" and substitute "subsection".
