TO 1999 SENATE BILL 119

1 At the locations indicated, amend the bill as follows:

2 1. Page 2, line 4: delete the material beginning with "if" and ending with

3 "interest," on line 6 and substitute *NO TP*

4 *NO TP* "if the beneficiary to whom a death benefit is payable is a dependent of the  
5 participating employe natural person, or a trust in which such a beneficiary has a  
6 beneficial interest,".
