TO 1999 SENATE BILL 195**

1 At the locations indicated, amend the substitute amendment<sup>✓</sup> as follows:

2 **1.** Page 1, line 8: after that line insert:

3 "**SECTION 1m.** 146.83 (1) (b) <sup>X</sup> of the statutes, as affected by ~~1999 Wisconsin Act~~  
4 1999 Wisconsin Act .... (this act), is repealed and recreated to read:

5 146.83 (1) (b) Receive a copy of the patient's health care records upon payment  
6 of reasonable costs."<sup>✓</sup>

7 **2.** Page 2, line 2: after that line insert:

8 "**SECTION 2m.** <sup>✓</sup> 146.83 (1) (c) <sup>X</sup> of the statutes, as affected by ~~1999 Wisconsin Act~~  
9 1999 Wisconsin Act .... (this act), is repealed and recreated to read:

1           146.83 (1) (c) Receive a copy of the health care provider's X-ray reports or have  
2           the X-rays referred to another health care provider of the patient's choice upon  
3           payment of reasonable costs." ✓

7           **4.** Page 3, line 9: after that line insert:

8           "SECTION 5m. ✓ 908.03 (6m) (d) ✓ of the statutes, as affected by ~~1999 Wisconsin Act~~  
9           1999 Wisconsin Act .... (this act), <sup>sections 4 and 5,</sup> is repealed and recreated to read:

10           908.03 (6m) (d) *Fees*. The department of health and family services shall, by  
11           rule, prescribe uniform fees based on an approximation of the actual costs that a  
12           health care provider may charge under par. (c) 3. for certified duplicate health care  
13           records. The rule shall also allow the health care provider to charge for postage or  
14           other delivery costs." ✓

18           908.03 (6m) (d) of the statutes takes <sup>e</sup> effect on the first day of the 37th month  
19           beginning after publication."
