The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 SECTION 1. 939.50 (1) (intro.) of the statutes is amended to read: ✓
4 939.50 (1) (intro.) Except as provided in ss. 948.035 (1), 946.83 and 946.85,
5 felonies in chs. 939 to 951 are classified as follows:
