
# **SENATE BILL 215** Suggested Amendments

196.637 Deferred payment agreements. If a public utility and a customer enter into a deferred payment agreement regarding a delinquent account, the public utility may not report the delinquency to a credit reporting agency unless the customer fails to comply with the agreement.

A public utility may report a customer's outstanding current balance to a credit reporting agency. If the outstanding current balance is reported, the public utility shall also report the ustomer's current payment as having been timely made unless the customer has failed to comply with the deferred payment agreement.

If a public utility reports a delinquency in error, it shall correct the error within 30 days of notice of such error, and the public utility shall not be subject to a fine or forfeiture unless it fails to correct the error within 30 days of notice of such error.

AN ACT to create 196.637 of the statutes; relating to: deferred payment

Sagreements between public utilities and customers

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

**SECTION 1.** 196.637 of the statutes is created to read:

196.637 Deterred payment agreements. (1) If a public utility has reported a customer's delinquent account to a credit reporting agency and the public utility and the customer enter into a deferred payment agreement regarding the delinquent account, the public utility shall report the terms of the agreement and the customer's subsequent payment history with respect to the account to the credit reporting agency.

(2) A public utility that makes an error in reporting a customer's delinquent account, or in reporting a customer's payment history under sub. (1), to a credit

reporting agency shall correct the error and notify the credit reporting agency no

later than 30 days after the public utility has notice of the error.
