2	1. Page 2, line 9: delete "or 341.266" and substitute ", 341.266 or 341.268".
3	2. Page 4, line 5: after that line insert:
4	"Section 9m. 341.268 (title), (2) (c), (d) and (e) 3. and (3) of the statutes are

6	341.268 (title) Reconstructed, replica, street modified and homemade

8	(2) (c) The department shall furnish the owner of the vehicle with registration
9	plates plate of a distinctive design in lieu of the usual registration plates, and those
10	plates. The plate shall show that the vehicle is a reconstructed, replica, street
11	modified or homemade vehicle owned by a Wisconsin hobbyist. Upon application, the
12	owner may reregister the vehicle without the payment of any additional fee.

- (d) Each The department shall issue to each hobbyist applying for a reconstructed, replica, street modified or homemade vehicle registration plates will be issued plate a hobbyist's identification number which will appear on each the plate. Second and all subsequent registrations under this section by the same hobbyist will bear the same hobbyist's identification number followed by a suffix letter for vehicle identification.
- (e) 3. Except as provided in s. 341.09 (7), no reconstructed, replica, street modified or homemade vehicle may be operated upon any highway of this state during the month of January unless the owner of the vehicle reregisters the vehicle under s. 341.25 and replaces the distinctive registration plates plate issued under par. (c) with regular registration plates or transfers regular registration plates to the vehicle.
- (3) In addition to the fee in sub. (2) (b), there shall be an original (first time only) processing fee of \$50 to defray the cost of issuing the original hobbyist's reconstructed, replica, street modified or homemade vehicle registration plates plate and to ensure that each hobbyist will be issued only one hobbyist's identification number.".
- 3. Page 4, line 9: delete "and 341.266 (2) (c)" and substitute ", 341.266 (2) (c) and 341.268 (2) (c)".
