#### 1999 BILL

AN ACT to repeal 20.115 (2) (i), 70.425 and 95.15; and to amend 74.23 (1) (a) 2., 74.25 (1) (a) 2., 74.25 (1) (a) 3., 74.25 (1) (a) 5., 74.30 (1) (b), 74.30 (1) (c) and 74.30 (1) (e) of the statutes; relating to: discontinuing the occupational tax on owners of domestic mink.

#### Analysis by the Legislative Reference Bureau

This bill discontinues the occupational tax on owners of domestic mink. The proceeds of the tax are now used for research on the breeding and raising of domestic mink.
