Julie,

In talking with Joe Maassen from DOT, we arrived at the following language to be added to SB 260 (together with the language in LRBa0908/1);

Page 2, line 6: after the period insert "This subsection does not apply to a state authority's data base that does not include the subjects' dates of birth."

Page 2, line 9: after the period insert: "This subsection does not apply to information obtained from a state authority's data base that does not include the subjects' dates of birth."

Also, Dan Schmidt and I weren't sure why "a record containing" is included on page 2, lines 3 and 4 since there is no parallel language on page 2, line 7. If it isn't needed, any amendment that we draft to address the above language could delete these words.

Can you let me know if you want me to forward these changes to the LRB. Thanks.
