1 AN ACT *to amend* 118.019 (2) (intro.) and 118.019 (2) (e); and *to create* 118.019
2 (2m) of the statutes; **relating to:** requiring school boards that provide
3 instruction in human sexuality and related subjects to provide instruction in
4 marriage and parental responsibility.

Analysis by the Legislative Reference Bureau

Current law permits a school board to provide instruction in human sexuality, reproduction, family planning, human immunodeficiency virus and acquired immunodeficiency syndrome, prenatal development, childbirth, adoption, available prenatal and postnatal support and male responsibility. This bill provides that if a school board offers instruction in any of these subjects, it must also offer instruction in marriage and parental responsibility.

For further information see the *local* fiscal estimate, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

5 SECTION 1. 118.019 (2) (intro.) of the statutes is amended to read:
6 118.019 (2) SUBJECTS. (intro.) A school board may provide an instructional
7 program in human growth and development in grades kindergarten to 12. If

4 **SECTION 2.** 118.019 (2) (e) of the statutes is amended to read:

5 118.019 (2) (e) Human sexuality; reproduction; family planning, as defined in
6 s. 253.07 (1) (a), including natural family planning; human immunodeficiency virus
7 and acquired immunodeficiency syndrome; prenatal development; childbirth;
8 adoption; and available prenatal and postnatal support; ~~and male responsibility.~~

9 **SECTION 3.** 118.019 (2m) of the statutes is created to read:

10 118.019 (2m) MARRIAGE AND PARENTAL RESPONSIBILITY. If a school board provides
11 instruction in any of the areas under sub. (2) (e), the school board shall also provide
12 instruction in marriage and parental responsibility.

13 **SECTION 4. Effective date.**

14 (1) This act takes effect on the first day of the 13th month beginning after
15 publication.
