2 1. Page 6, line 11: delete lines 11 to 16 and substitute:

3 "SECTION 2<sup>b</sup> 186.01 (2) of the statutes is amended to read:

4 186.01 (2) "Credit union" means, except as specifically provided <sup>in</sup> ~~under~~ ss.  
5 186.41 (1) and 186.45 (1), a cooperative, nonprofit corporation, incorporated under  
6 this chapter to encourage thrift among its members, create a source of credit at a fair  
7 and reasonable cost and provide an opportunity for its members to improve their  
8 economic and social conditions."
