TO 1999 SENATE BILL 292

1 At the locations indicated, amend the bill as follows:

2 1. Page <sup>3</sup> ~~2~~, line <sup>9</sup> ~~2~~: after that line insert:

3 "(e) A county shall return all money collected under this <sup>✓</sup> subsection in  
4 connection with a person's confinement unless one of the following occurs:

5 1. The person is convicted of a crime<sup>✓</sup>, as defined in s. 939.12, based on the  
6 conduct that led to the person's confinement.

7 2. The person is charged with another crime while the criminal complaint, as  
8 described in s. 968.01 (2)<sup>✓</sup>, based on the conduct that led to the person's confinement  
9 is pending and the person is convicted of the other crime."
