Representative Underheim:

*Synar* This amendment deletes Sections 7, 8 and 9 of SSA1 to SB334. Section 8 repeals the current law provision in s. 254.916(4) that prohibits DHFS from including the results of an investigation in a ~~SYNAR~~ survey if the investigation does not meet certain statutory requirements. ~~Merely~~ deleting Section 8 results in an incorrect reference to a ~~SYNAR~~ survey. Section 254.916(4) currently refers to a ~~SYNAR~~ survey as a survey conducted under s. 254.916(1). As Section 6 of SSA1 deletes any reference to a ~~SYNAR~~ survey in s. 254.916(1), s. 254.916(4) should be amended to clarify that the survey referred to is a ~~SYNAR~~ survey conducted under federal law.

Representative Underheim:

This amendment deletes Sections 7, 8 and 9 of SSA 1 to SB-334. Section 8 repeals the current law provision in s. 254.916 (4) that prohibits DHFS from including the results of an investigation in a Synar survey if the investigation does not meet certain statutory requirements. Deleting Section 8 (which returns s. 254.916 (4) to current law) results in an incorrect reference to a Synar survey. As Section 6 of SSA 1 deletes any reference to a Synar survey in s. 254.916 (1), s. 254.916 (4) should be amended to clarify that the survey referred to is a Synar survey conducted under federal law.
