4 3. Page 5, line 11: after "racial" insert "or ethnic".

5 4. Page 5, line 13: after "racial" insert "or ethnic".

6 5. Page 5, line 19: delete that line and substitute "result of racial or ethnic
7 profiling, racial or ethnic stereotyping or other race-based or ethnicity-based
8 discrimination or".

9 6. Page 7, line 6: delete that line and substitute "designed to prevent the use
10 of race or ethnicity, racial or ethnic profiling, racial or ethnic stereotyping or other".

11 7. Page 7, line 7: after "race-based" insert "or ethnicity-based".
