1999 BILL

AN ACT to consolidate, renumber and amend 289.645 (3) (intro.) and (a) of the statutes; relating to: increasing the recycling fee imposed on the disposal of solid waste.

Analysis by the Legislative Reference Bureau

Current law imposes a recycling fee of 30 cents per ton for solid waste, other than certain kinds of high—volume industrial waste, disposed of at a landfill or other waste disposal facility. This type of fee is often called a tipping fee. The recycling fee is deposited in the recycling fund.

This bill increases the recycling fee to \$2.00 per ton.
