SECTION 200 66.05 (9) (e) of the statutes is created to read:

66.05 (9) (e) In this paragraph, in addition to the meaning given under par. (a) in., "historic building" means a building that is eligible for listing on the national register of historic places in Wisconsin or the state register of historic places. If a historic building is acquired or proposed to be acquired by a local cultural arts district created under subch. V of ch. 229, the historic building may not be razed and removed unless the local cultural arts district determines that there is no reasonable alternative to demolition of the historic building."
