**Assumptions Used in Arriving at Fiscal Estimate**

LRB 3050/3, Section 8, requires that every provider that provides intralata calls (priced on a time basis) needs to either certify to the Public Service Commission (PSC) that it is in compliance or file a plan with the PSC on how it will get in compliance. A provider would include local exchange companies, competitive local exchange companies, carriers and resellers. The PSC estimates the number of these entities to exceed 500

Under the provisions of Section 8, the PSC would need to inform providers of the law, follow-up with those that do not file, track and file certificates, and review and respond to plans that are filed. This additional workload would be absorbed by existing staff.

There are no local government costs associated with this bill.


