1 AN ACT *per cat*; relating to: the student member of the board of regents of the
2 University of Wisconsin System.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 SECTION 1. 15.91 of the statutes is amended to read:

4 **15.91 Board of regents of the University of Wisconsin System; creation.**

5 There is created a board of regents of the University of Wisconsin System consisting
6 of the state superintendent of public instruction, the president, or by his or her
7 designation another member, of the technical college system board and 14 citizen
8 members appointed for staggered 7-year terms, and a student enrolled at least
9 half-time and in good academic standing at an institution within the University of
10 Wisconsin System who is at least 18 years old and a resident of this state, for a 2-year
11 term. The student member may be selected from recommendations made by elected
12 representatives of student governments at institutions within the University of

1 Wisconsin System. The governor may not appoint a student member from the same
2 institution in any 2 consecutive terms. If the student member loses the status upon
3 which the appointment was based, he or she shall ~~cease to be~~ remain a member of
4 the board of regents until the expiration of his or her term.
