Whereas, Norway, which means Northern Way, is the 5th largest country in Europe, covering 125,052 square miles, and has a population of approximately 4,000,000; and

Whereas, Norwegian culture can be found throughout Wisconsin in the cuisine of lutefisk and lefse, in the art of rosemalling, and the presence of wood carved trolls; and

Whereas, Wisconsin communities, such as Stoughton, Blair, Westby and Woodville, will celebrate Syttende Maio in many ways, including parades, Norwegian displays, Norwegian street music and dancers, Syttende Mai King and Oueen presentations, Syttende Maioruns, special museum tours, choral concerts, church services and Norwegian drama; and

Whereas, thousands of Wisconsin citizens of Norwegian heritage will participate in these activities during the month of May; now, therefore, be it

Resolved by the senate, the assembly concurring, That the weekend of May 14, 15 and 16, 1999, is proclaimed "Syttende Mai Weekend" in the state of Wisconsin, and that all of the citizens of this state are declared honorary Norwegians for that weekend and are urged to observe the Syttende Mai Weekend with appropriate celebrations.
