1999 SENATE JOINT RESOLUTION

1 **Relating to:** creating a committee of conference on 1999 Assembly Bill 133, the
2 executive budget bill of the 1999 legislature.

3 **Resolved by the senate, the assembly concurring, That,** upon the adoption
4 of this joint resolution by the senate and concurrence therein by the assembly and
5 notwithstanding joint rule 3 (intro.), there is created a committee of conference on
6 1999 Assembly Bill 133, relating to state finances and appropriations, constituting
7 the executive budget bill of the 1999 legislature, to reconcile the differences between
8 the 2 houses and to present its report on the bill to the 2 houses; and

9 **Be it further resolved, That,** notwithstanding joint rule 3 (1), senate rules 4
10 (9) and 35 and assembly rule 40 (1):

11 (1) The committee of conference on 1999 Assembly Bill 133 shall consist of 4 [✓]5
12 members from each house.

13 (2) The members of the committee of conference on 1999 Assembly Bill 133
14 shall be appointed by the speaker of the assembly in the case of assembly members

1 and be appointed by the president of the senate, without approval of the senate, in
2 the case of senate members.

3 (3) The report by the committee of conference on 1999 Assembly Bill 133 must
4 be supported by the votes of at least 3 of the 4 members representing each house.
