1999 SENATE RESOLUTION 7

March 29, 2000 - Introduced by Senators ERPENBACH and RISSER. Referred to Committee on Senate Organization.

1 **Relating to:** commending the University of Wisconsin women's basketball team on
2 its recent WNIT tournament appearance.

3 Whereas, the 1999-2000 University of Wisconsin women's basketball team has
4 an excellent recruitment, training and coaching staff, including Head Coach Jane
5 Albright; and

6 Whereas, the University of Wisconsin women's basketball team achieved its 4th
7 20-win season in the past 6 years and subsequently advanced to its second
8 consecutive WNIT championship final with a 78-60 win over Colorado State on
9 Saturday, March 25, 2000; and

10 Whereas, this is the 3rd straight year a Big Ten team has been a WNIT finalist
11 and the second consecutive year that the University of Wisconsin women's basketball
12 team has participated in the WNIT tournament; and

13 Whereas, the University of Wisconsin women's basketball team has the 2nd
14 highest RPI statistics and has played the second strongest team schedule (25th); and

1 Whereas, the University of Wisconsin women's basketball team tied its own
2 WNIT record for greatest winning margins with a 37-point victory over Fairfield and
3 is holding WNIT opponents to .349 percent from the floor, while hitting .461 percent;
4 now, therefore, be it

5 ***Resolved by the senate, That*** the members of the senate of the state of
6 Wisconsin commend and congratulate the University of Wisconsin women's
7 basketball team for its hard work and dedication in advancing women's basketball
8 to its highest level and share the pride of the citizens of the state of Wisconsin in their
9 team achievement; and, be it further

10 ***Resolved, That*** the senate chief clerk shall provide copies of this resolution to
11 Head Coach Jane Albright and each member of the team.
