#### Resolved by the senate, the assembly concurring, That:

SECTION 1. Adjournment. Except for the consideration of executive vetoes or partial vetoes, the adoption of and concurrence in this joint resolution by both houses and a motion to adjourn pursuant to this joint resolution adopted in each house shall constitute the final adjournment of the October 1999 special session of the legislature.

SECTION 2. Bills to governor. Notwithstanding 1999 Senate Joint Resolution 1, section 1 (2) (n), no later than December 1, 1999, the chief clerk of each house shall submit to the governor for executive action any enrolled bill originating in the chief clerk's house during the special session.
