SENATE JOINT RESOLUTION

1 **Relating to:** the final adjournment of the October 1999 special session.

2 ***Resolved by the senate, the assembly concurring, That:***

3 **SECTION 1.** Adjournment. Except for the consideration of executive vetoes or
4 partial vetoes, the adoption of and concurrence in this joint resolution by both houses
5 and a motion to adjourn pursuant to this joint resolution adopted in each house shall
6 constitute the final adjournment of the October 1999 special session of the
7 legislature.

8 **SECTION 2.** Bills to governor. Notwithstanding 1999 Senate Joint Resolution
9 1, section 1 (2) (n), no later than December 1, 1999, the chief clerk of each house shall
10 submit to the governor for executive action any enrolled bill originating in the chief
11 clerk's house during the special session.

1 **SECTION 3.** Veto review. The October 1999 special session shall reconvene upon
2 a call of a majority of the members of the joint committee on legislative organization
3 solely for the consideration of executive vetoes or partial vetoes.
