I-NOTE

1 **Relating to:** the final adjournment of the May 2000 special session.

2 ***Resolved by the senate, the assembly concurring, That:***

3 **SECTION 1. Adjournment.** Except for the consideration of executive vetoes or
4 partial vetoes, the adoption of and concurrence in this joint resolution by both houses
5 and a motion to adjourn pursuant to this joint resolution adopted in each house shall
6 constitute the final adjournment of the May 2000 special session of the legislature.

7 **SECTION 2. Veto review.** The May 2000 special session shall reconvene upon
8 a call of a majority of the members of the joint committee on legislative organization
9 solely for the consideration of executive vetoes or partial vetoes.
