1999-01 BUDGET BILL: Appropriation Language for Office of Crime

Victim Services

The Department of Justice requests that language be drafted for the 1999-01 budget bill, to create a new appropriation relating to federal moneys to be received and administered by our Office of Crime Victim Services. Currently, OCVS has two federal appropriations, which are linked to victim compensation and victim assistance, respectively. The Office needs, and does not currently have, "generic" authority to receive and spend federal moneys. For example, as a departmental management prerogative, we have moved administrative responsibility for federal moneys received under the Children's Justice Act, from Legal Services to Crime Victim Services. Because OCVS lacks the right type of federal appropriation language, the budget, etc., has had to stay in our appropriation (1)(m).

As a remedy, we request the creation of a PR-F continuing appropriation, entitled *Federal aid* or *Federal aid*, *state operations*. Its Chapter 20 designation should be something like 20.455(5)(ma). The Chapter 20 language could read something like

(ma) Federal aid, state operations. All moneys received as federal aid, as authorized by the governor under s. 16.54, for state operations.


