Trauma System Implementation Date

Current Language

Recently passed legislation, 1997 Act 154, requires DHFS to develop and implement a statewide trauma system. Wis. Stat. 146.56 (1) specifically states, "Not later than July 1, 2001, the department shall develop and implement a statewide trauma system."

Proposed Change

Change the development and implementation date in Wis. Stat. 146.56 from July 1, ~~2000~~²⁰⁰¹ to July 1, 200~~1~~².

Effect of the Change

The effect of the proposed change will give the Department adequate time to comply with mandated duties specified in 1997 Act 154.

Rationale for the Change

No staff positions were authorized in 1997 Act 154. The fiscal note attached to the bill estimated that a minimum of 2.0 FTE positions would be necessary to successfully administer the program. Similar programs in other states typically have 2.0 to 5.0 FTE positions allocated for program administration. Act 154 directs the Department to write rules, develop and disseminate protocols, classify hospital capabilities, assist with regional advisory committees and set-up data collection and analysis. In addition, staff position(s) are needed to support and do follow-up work for the advisory committee meetings. Without any position(s), the Department may not be able to perform the mandated duties of Act 154.

As part of its 1999-01 biennial budget request, the Department is requesting 1.0 GPR FTE in SFY 2001 to administer the program. However due to the late hiring date, additional time is needed to comply with the requirements of Act 154.
