Issue/Topic: DRY CLEANER ENVIRONMENTAL RESPONSE PROGRAM

Proposed Change:

The Department proposes to amend Wis. Stat. Ch 292.66(3) to change the maximum reimbursement amount for interim remedial actions, and change the fund payment to a co-payment system involving the eligible applicant and the fund account.

The Department proposes a change to a 50/50 co-pay with the fund and the eligible applicant cleaning up the site. This would include a \$40,000 facility maximum (\$20,000 from the applicant and \$20,000 from the fund), and a maximum of \$6,000 for investigative costs (\$3,000 from the applicant and \$3,000 from the fund).

Explanatory Note:

The change in funding allotment represents the original proposal by the dry cleaning industry. The Department and the dry cleaning industry recognize the current limits are inadequate to cover interim action costs. A 50/50 co-payment system is an equitable reimbursement method and helps preserve future funding availability.
