<u>Proposed Change</u>: The current grant program is scheduled to sunset at the end of the 1997-99 biennium. The sunset provision in s. 26.145, Stats. needs to be removed for the program to be reauthorized for the 1999-01 biennium.

Explanatory Note: The legislature authorized the Fire Department Equipment Grant Program in the 1997-99 biennial budget, but specified that the program be a pilot program for the 1997-99 biennium only with a sunset date of June 30, 1999. In order for the grant program to be re-authorized as requested by the Department, the sunset date must be removed.

Desired Effective Date: July 1, 1999 or the effective date of the biennial budget.
