PROBLEM

The restrictive eligibility criteria for the Employment Skills Advancement Program (ESAP) have contributed to extremely low participation rates. Two modifications to the statutory language will address the most prohibitive criteria, while maintaining the intent that participants demonstrate workforce attachment and a personal commitment to continuing education and training.

PROPOSED CHANGE

Amend s.49.185(3)(d), Stats., as follows, to provide for a shorter required duration in unsubsidized employment:

(3)(d) The individual has been employed in an unsubsidized job for at least $9 \underline{6}$ consecutive months before applying for a grant.

Amend s.49.185(3)(i), Stats., as follows, to provide for a straight match, rather than a second and a third party match:

(3)(i) The individual contributes, or obtains from other sources, an amount at least equal to the amount of the grant, and obtains funding from other sources in an amount at least equal to the amount of the grant, for tuition, books, transportation or other direct costs of the training or education.

EXPLANATORY NOTE

Reducing the required time that the applicant has been in an unsubsidized job from 9 months to 6, in combination with the requirement that the applicant is currently employed full-time in an unsubsidized job, maintains the intent of workforce attachment without overly restricting access to the program.

Changing ESAP to a straight matching grant will, without overly restricting access to the program, require the intended personal commitment from the applicant, who will need to work toward procuring the matching funds in the form of personal funds, a scholarship, or a community, business or other grant.

FISCAL IMPACT

Funding for the ESAP program is sum certain. The fiscal impact of the proposed change will be limited to the possible expenditure of all funds appropriated for the program, rather than the fraction which will likely result from low participation rates given current eligibility criteria.
