PROBLEM

DES has adopted a policy we believe to be in the public interest and good administration that requires a request for burial (funeral and cemetery) reimbursement be made within 12 months of the recipient's death.

PROPOSED CHANGE

Add to s. 49.30 that requires an application for reimbursement under that section be made by the recipient's representative within 12 months of the recipient's death.

EXPLANATORY NOTE

In a fair hearing (MED-43/17817, Oneida County) the hearing officer found DES had no administrative rule nor statutory basis for this policy. The application for reimbursement in this case was far past 12 months. The hearing officer found in favor of the recipient's representative.

FISCAL IMPACT

Doing this change will reduce expenditures in staff time and salary in searching associated records for eligibility when requests for reimbursement is made long after the recipient's death. It may also have some reduction in the amount actually expended for reimbursements, but this should be minimal; requests for reimbursements beyond the 12 month period are believed to be quite infrequent.
