**E. STREAMLINE FUNERAL DIRECTOR RENEWAL AND ELIMINATE
"GOOD STANDING" CERTIFICATE**

Summary and Justification

The statutes currently require that a renewal application submitted by a funeral director include the name of the funeral establishment where the funeral director is employed. Funeral directors who apply for renewal and who are not employed at a funeral establishment are granted a "funeral director in good standing" certificate. This amendment eliminates the requirement that a funeral director be employed at a funeral establishment in order to renew and eliminates the "funeral director in good standing" certificate.

F. AUTHORIZE COUNTER FEE AND EXPEDITED SERVICE CHARGE

Summary and Justification

The department provides special services to applicants who appear at the department office and request that an application be processed immediately and who make requests by mail or telephone for special handling of applications. While in some instances requests for immediate processing cannot be honored, when an application can be handled immediately staff must usually reschedule other work and make accommodations in handling other duties. The cost of processing applications by providing counter services or special handling is greater than using standard procedures. To accommodate these requests the department is required to reassign duties, ask staff to work irregular schedules or overtime, and delay other work or process other work out-of-turn.

A special handling charge and counter service charge are added to the standard fee schedule for the department to reflect these additional costs. The fee is to be set by rule at the approximate cost to the department for providing the counter service or special handling service.

Proposed Statutory Language

Section 440.05 (10) of the statutes is created to read:

440.05 (10) Special transaction fees. The department shall charge a fee established by rule for counter services and for processing credential applications with a special handling request for fast service. The fee shall approximate the cost to the department for providing the counter service or special handling service.
